## Programme of Work for the Session.

Sub-Committee.-The Council have appointed a Scientific Sub-Committee consisting of the Scientific Secretary and four other members of the Council. This Sub-Committee will direct the observational and educational work of the Society under the Council. The following have already been taken up:-
(a) Instructions and classes for members who are beginners. These will be conducted through the medium of the post and over 50 members have already joined. Those who have not done so are requested to communicate immediately with the Director of Classes.
(b) Public Lectures.-The programme of public Iectures for this session has been worked through, and, the Council are able to say, with most gratifying success. The lectures were all delivered at the Town Hall, Calcutta. The first lecture by the Hon. Mr. W. A. Lee was before a crowded audience, on the 15th January 1913, his subject being "The LifeHistory of a World," and was illustrated by a most interesting series of lantern-slides. The Chairman on the occasion was the Hon. Sir F. W. Duke. The second lecture was on "The Sun," and was delivered on the 17th February by Dr. D. N. Mullick, D.Sc., F.R.S.E., with the Hon. Sir Richard Harington as Chairman. It was liberally illustrated by lantern-slides, and provec. very successful. The third lecture was delivered on the 21st February by the Rev. J. Mitchell, M.A., F.R.A.S., his subject being "Comets." Justice Sir Ashutosh Moozerjee was in the chair. This, the concluding lecture for the session, was illustrated with a most remarkable series of lantern-slides and made a profound impression on the audience present.
(c) A Conversazione was held at the Town Hall, on the 29th January 1913, where a collection of drawings, photographs, instruments and other objects of interest was put up. A detailed account of it appeared in the February issue of the Journal.
(d) The Society possesses a four-inch reflecting telescope which is available for use by members residing at Calcutta. Any desirous of making use of it are requested to communioate with the Secretary.
